BY THE COMMISSION:

On August 31, 2015, Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or
"Company") filed an Application with the Arizona Corporation Commission ("Commission") for a
rate increase.

On October 6, 2015, Arizona Solar Energy Industries Association's ("AriSEIA") filed an
Application to Intervene in this docket. AriSEIA is a non-profit trade association that represents local
and national companies whose mission is to promote policies that promote greater use of solar energy
in Arizona.

On October 26, 2015, by Procedural Order, AriSEIA was granted intervention.

On March 22, 2016, AriSEIA filed a Notice of Change of Representative from Mark Holohan
to Thomas A. Harris, and a Consent to Email Service by Mr. Harris.

A Procedural Order was issued on April 1, 2016, granting AriSEIA's request. In this Procedural
Order, Intervenor, Energy Freedom Coalition of America ("EFCA"), was inadvertently left off the
service list. This Procedural Order amends the service list to include EFCA.


IT IS THEREFORE ORDERED that the request by AriSEIA to receive service of all filings in
