PROCEDURAL ORDER

BY THE COMMISSION:

On January 26, 2016, Southwest Gas Corporation (“SWG”) filed an application to update its Schedule T-1 (Transportation of Customer-Secured Natural Gas - Tariff Sheets No. 54, 56, 57 and 63 in order to comply with Federal Energy Regulatory Commission (“FERC”) Order 809.

On March 21, 2016, one consumer comment was docketed by Chairman Doug Little’s office.

On April 1, 2016, the Commission’s Utilities Division (“Staff”) filed a Notice of Administrative Approval / Closure (“Notice”). The Notice included a stamped copy of the approved new Schedule T-1, which became effective by operation of law on April 1, 2016. Staff requested administrative closure of this docket.

No further filings have been made in this docket.
