**MOTION FOR EXTENSION OF TIME**

The Utilities Division ("Staff") of the Arizona Corporation Commission hereby files a request for an extension of time to file its Staff Report or Direct Testimony in this matter. Under Arizona Administrative Code R14-1-103 (B) (11) (b) for a Class D utility, Staff is required to file its Staff Report within 75 days of sufficiency. Sufficiency was issued on March 29, 2016. However, because of the complexity of the application, Staff will need more time to process the application. Staff would request an additional 45 days to file its Staff Report or Direct Testimony. Staff would also request that the Company file its response to the Staff Report or Rebuttal testimony 30 days later. Staff has conferred with the Company and the Company is in agreement with the proposed schedule.
