I and my family are looking forward to getting safe and reliable drinking water from NTUA. I am in favor of paying the \$500.00 to NTUA. I hope that you all (Arizona Corporation Commissionaires) take our complaints in consideration and agree with the transfer to NTUA and have them take over the water company.
