BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission (“Commission”) finds, concludes, and orders that:

FINDINGS OF FACT

1. On April 6, 2004, the Commission issued Decision No. 66904, approving LDC Enterprises, Inc. dba Full Serv Gas’ (“LDC” or “Company”) application for a Certification of Convenience and Necessity (“CC&N”) to provide customer owned pay telephone (“COPT”) services within the State of Arizona.

2. On February 16, 2016, LDC filed an application with the Commission requesting to cancel its CC&N to provide COPT telecommunications services within the State of Arizona. The application indicated that LDC no longer provides, or never did provide, COPT services in the State of Arizona. The application further indicated that Ms. Mary Gibson is authorized to file the application on behalf of the Company and that she waives her right to notice and a hearing in order to cancel the CC&N.

3. On March 4, 2016, the Commission’s Utilities Division (“Staff”) filed a Staff Report in this matter, recommending approval of LDC’s application.

ORDER

IT IS THEREFORE ORDERED that LDC Enterprises, Inc. dba Full Serv Gas' Certificate of Convenience and Necessity granted in Decision No. 66904 (April 6, 2004) to provide customer owned pay telephone services in Arizona is hereby canceled.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.


