PROCEDURAL ORDER

BY THE COMMISSION:

On July 15, 2015, Community Water Company of Green Valley ("CWGV" or "Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase.

By Procedural Order dated August 24, 2015, the matter was set for hearing to commence on May 12, 2016, and other procedural guidelines established, including a pre-hearing conference on May 3, 2016.

Subsequently, a Commission Open Meeting was scheduled for the same date and time as the pre-hearing conference.

No party intervened in this matter; there are no pre-hearing motions filed or anticipated; and neither the Company nor the Commission's Utilities Division ("Staff") believes that a pre-hearing conference is necessary in this matter. Any procedural matters can be addressed at the beginning of the hearing.

IT IS THEREFORE ORDERED that the May 3, 2016 pre-hearing conference is vacated.


