On November 5, 2015, Tucson Electric Power Company ("TEP" or Company") filed an Application with the Arizona Corporation Commission ("Commission") for a rate increase ("Rate Case").

By Procedural Order dated December 14, 2015, the Rate Case was set for hearing to commence on August 31, 2016, and other procedural guidelines were established.

By Procedural Order dated April 6, 2016, the Rate Case was consolidated with TEP's 2016 REST Implementation Plan (Docket No. E-01933A-15-0239).

On April 20, 2016, Kevin M. Koch, a TEP customer and owner of Technicians for Sustainability which installs solar systems in TEP's service area, filed a request to intervene in the Rate Case.

No party opposed Mr. Koch's request to intervene.


