Dear Sir or Madam:

The City of Globe and Arizona Water Company recently entered in to a settlement agreement regarding water service areas. As a result of this agreement, you will no longer be receiving City of Globe water. We will be working together with Arizona Water Company in order to make this the smoothest transition possible.

In the next few weeks, Arizona Water staff will be replacing your water meter and notifying City of Globe of the date and meter reading so that we can finalize the water portion of your bill.

For those customers who have City of Globe sewer and/or garbage service, you will continue to receive a monthly bill from us that will still be due on the 15th of each month as it has been in the past.

Please be informed that for any bills that become delinquent, according to City Code 9-4-2 Billing-Delinquent Accounts – The City of Globe has the authority to disconnect a service from a property for any outstanding balance after a fifteen (15) day written notice if the balance remains unpaid. Although you will only be paying sewer and/or garbage to the City of Globe, this City Code still applies as the sewer could be plugged and/or the garbage containers could be removed. If either of these situations occurs, there will be reconnection fees and/or deposits required to re-establish service.


