STAFF'S MOTION FOR CONSOLIDATION

On March 16, 2016, Eagletail Water Co., LLC (“Eagletail” or “Company”) filed an application for financing approval to enter a \$174,500 loan and encumber its utility assets as security for that indebtedness. Docket No. W-03936A-16-0095. The stated purposes for the loan is to cover the estimated cost of a new 250,000 gallon storage tank including site preparation and interconnection with the existing water system.


Also on March 16, 2016, Eagletail filed a general rate application seeking a rate increase which, among other things, would produce the revenue increase necessary to provide debt service on the \$174,500 in debt the Company seeks to incur. Docket No. W-03936A-16-0096. The Company’s rate application was found sufficient on May 11, 2016.

Arizona Corporation Commission (“Commission”) Utilities Division (“Staff”) hereby moves to consolidate Docket Nos. W-03936A-16-0095 and W-03936A-16-0096. The issues presented within these dockets are substantially related and no parties’ rights will be prejudiced by consolidation. Staff believes that the consolidation of these matters will improve the efficient processing of these requests and will aid the Commission in its evaluation of both matters.


