Staff of the Arizona Corporation Commission ("Staff") respectfully requests that the Hearing Division issue a procedural order scheduling the following additional dates for hearing and briefing in this matter.

June 8, 2016	Testimony by APS Witness on Responses to Staff's Third Set of Data Requests
June 9, 2016	Testimony by TEP and UNSE Witness on Responses to Staff's Second Set of Data Requests
June 13, 2016	Responsive testimony or written responsive filings by Staff and other Parties
June 20, 2016	Initial Briefs due
July 8, 2016	Reply Briefs due

Most of these dates were agreed to by the Parties at the hearing on May 6, 2016 in this matter. Since then, an additional day of hearing on June 9, 2016 was agreed to by the Parties participating in the hearing on this matter, with the exception of the IBEW. IBEW did not respond to Staff's email regarding the additional day of hearing.<sup>1</sup>


