BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission (“Commission”) finds, concludes, and orders that:

FINDINGS OF FACT

1. On September 7, 2004, the Commission issued Decision No. 67237, approving R. Scott De Long dba De Long Industries Group’s (“De Long” or “Company”) application for a Certificate of Convenience and Necessity (“CC&N”) to provide customer owned pay telephone (“COPT”) services within the State of Arizona.

2. On February 22, 2016, De Long filed an application with the Commission requesting to cancel its CC&N to provide COPT telecommunications services within the State of Arizona. The application indicated that De Long no longer provides, or never did provide, COPT services in the State of Arizona. The application further indicated that Mr. R. Scott De Long is authorized to file the application on behalf of the Company and that he waives his right to notice and a hearing in order to cancel the CC&N.

3. On April 1, 2016, the Commission’s Utilities Division (“Staff”) filed a Staff Report in this matter, recommending approval of De Long’s application.



**ORDER**


