Preferred Long Distance, Inc. ("Preferred") submits to the Arizona Corporation Commission an original and thirteen (13) copies of amended Sheet Nos. 1 and 39 to Preferred's Arizona switched access Tariff, Arizona C.C. Tariff No. 2, for incorporation into the Company's Tariff.

With this submission, Preferred complies with the Federal Communications Commission's ("FCC") *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. No. 11, filed on June 16, 2016 and effective on July 1, 2016.

A July 1, 2016 effective date is requested to enable the Company to comply with the above cited orders and rule.


