NOTICE OF COMPLIANCE

Pursuant to Decision Nos. 72026 (December 10, 2010) and 74437 (April 18, 2014), Liberty Utilities (Litchfield Park Water & Sewer) Corp. (the "Company") hereby files this Notice of Compliance in the above-captioned consolidated matter. Decision Nos. 72026 and 74437 require the Company to file, as a compliance item, a low income tariff report showing the number of participants for the preceding year, discounts given, administrative and carrying costs, and collections made through the commodity surcharge.¹

1 Attached is **Exhibit 1** which is intended to meet the compliance requirements due
2 in 2014, 2015, and 2016, when the Company filed its annual reports. As is noted in the
3 exhibit, the proposed commodity surcharge is \$0.0063 per thousand gallons for water
4 customers and a fixed surcharge of \$0.11 per month for wastewater customers.
