**INTERVENOR GAYER'S MOTION TO AMEND TARIFF**

**To Insert on Sheets 92-94 "Monthly" between "EEP" and "Weather"**

Richard Gayer, an Intervenor herein, hereby moves to amend proposed tariff sheets 92 through 94 to insert "monthly" between "EEP" and "weather" in all places so that they read "EEP Monthly Weather Adjustment". This will complete the compliance of Southwest Gas with stipulated Order No. 74780 in Docket 13-0327. That order repeatedly refers to the "MWA", defined there as the "Monthly Weather Adjustment".

This amendment will clearly distinguish the "EEP Annual Adjustment" (Sheets 94-95) from its monthly relative and avoid confusing customers who lack legal, mathematical or other technical skills, thereby improving the utility's customer relations. See General Rate Case, Part 1, Item 7.3 at page 7: "Southwest Gas' proposed rate design strives to accomplish four objectives: (1) customer acceptance and understandability".
