On May 20, 2016, a request for intervention was docketed by Mr. Larry K. Nuzum. As Mr. Nuzum claims to be a customer of Navopache Electric Cooperative, Inc. ("NEC"), he is entitled to intervene provided his participation does not unduly broaden the issues theretofore presented. A.A.C. R14-3-105.B. Mr. Nuzum's request states:

"At one time the AZCC considered making public utilities go non-competitive to competitive. Utilities should be doing that on their own on all products."

Issues relating to whether Arizona public utilities should or should not be subject to competition or whether NEC should be competitively bidding all products are beyond the scope of the issues heretofore presented in this matter, are not the proper subject matter for a rate proceeding generally and certainly are inappropriate for a streamline rate application
