**NOTICE OF IMPLEMENTATION OF SURCHARGE
TRUXTON CANYON WATER COMPANY
DOCKET NO. W-02168A-15-0369: DECISION NO. 75553**

Decision No. 75453 authorized Truxton Canyon Water Company, Inc. ("Company") to obtain a 20-year amortizing loan not to exceed \$350,950 from the Water Infrastructure Finance Authority of Arizona ("WIFA") for arsenic treatment facilities.

At its Open Meeting on May 3, 2016, the Arizona Corporation Commission in Decision No. 75553 authorized the Company to implement a surcharge to become effective immediately.

The newly approved surcharge will add \$2.17 to the monthly bill for a customer with a 3/4-inch meter. Please see the surcharges below for all meter sizes.

3/4 Inch Meter	\$2.17
1 Inch Meter	\$3.61
1 1/2 Meter	\$7.23

NOTE: The above monthly surcharge is **in addition** to the current monthly rates and charges already in effect for the Company.
