Mr. Bersch and Mr. and Mrs. Wanzek filed a special action as an interlocutory appeal from the Administrative Law Judge's denial of their motion to dismiss. Mr. Bersch and Mr. and Mrs. Wanzek then filed an appeal following the entry of the final judgment dismissing the special action. The appeal is Arizona Court of Appeals Case No. 1 CA-CV 15-0340 ("the appeal"). On July 25, 2015, the Court of Appeals issued a stay of these proceedings.

On June 2, 2016, the Court of Appeals issued a decision on the appeal. A copy of the decision is attached. The decision affirms the judgment of the Superior Court and vacates the Court of Appeals' stay of these proceedings.
