On March 15, 2016, Wayward Winds (“Lazy C”), filed an application with the Arizona Corporation Commission (“Commission”) to cancel its existing Certificate of Convenience and Necessity for water service.

On June 1, 2016, the Commission’s Utilities Division filed a Sufficiency Letter in this docket indicating the application had met the sufficiency requirements as outlined in the Arizona Administrative Code (“A.A.C.”).
