Dear Mr. Brown:

This letter is to inform you of the Commission Staff's approval of your new PGA mechanism as well as the write-off of the PGA bank balance as of December 31, 1998. Staff agrees with the write-off of the December 31, 1998 bank balance of \$102,010.79.

Based upon discussions between Staff and Copper Market, it is our understanding that the new PGA mechanism would be the same as the existing PGA mechanism, with the addition of a trigger if the PGA bank balance exceeds \$20,000. The trigger would require Copper Market to file with the Commission for a review of the PGA rate within 45 days of the completion of the monthly bank balance exhibits that illustrate that the \$20,000 threshold has been exceeded. Additionally, Staff recognizes that Copper Market may file for a PGA rate change at other times if the company feels that such a filing is necessary.
