On August 18, 2015, Charter Communications, Inc. ("Charter") and Time Warner Cable Inc. ("TWC"), on behalf of itself and its wholly owned subsidiaries Time Warner Cable Information Services (Arizona), LLC ("TWCIS") and Time Warner Cable Business LLC ("TWCB") (collectively, the "Parties") notified the Commission of a transfer of ultimate indirect control of TWCIS and TWCB to Charter. The Commission Utilities Division determined in a Memorandum filed November 25, 2015 that the transfers of control did not require Commission approval and requested an order from the Hearing Division administratively closing the proceeding.

Charter hereby notifies the Commission that, on May 18, 2016, the transactions detailed in the August 18, 2015 notice were consummated and Charter (reorganized into "New Charter" as set forth in the August 18, 2015 notice) is now the ultimate parent of TWCIS and TWCB.¹

Going forward, the designated regulatory and customer service contact for TWCIS and TWCB regarding compliance with Arizona laws and regulations, including A.A.C. R14-2-1114(K), will be:

Appendix A supersedes the chart originally attached as Exhibit A to the August 18, 2015 notice to reflect the revised positioning of certain intermediary entities within Charter's corporate structure, but involves no material changes to either the control or the ultimate ownership of either TWCIS or TWCB.




