**NOTICE OF PARTIAL
SETTLEMENT
AND
REQUEST FOR PROCEDURAL
CONFERENCE TO ESTABLISH A
REVISED PROCEDURAL
SCHEDULE**

Trico Electric Cooperative, Inc. ("Trico" or "the Cooperative"), and the Arizona Corporation Commission Utilities Division ("Staff") hereby provide notice that they have reached an agreement in principle on the issues in this Docket and request a Procedural Conference to discuss a revised procedural schedule to allow the Commission to consider the Settlement Agreement, which is in the process of being drafted. Other intervenors in this Docket may agree to some or all of the settlement terms, may propose modification to the settlement terms and may join as signatories to the settlement agreement. In light of this agreement in principle, Trico and Staff request that the procedural schedule in this Docket be modified as set forth below except for public comment which is currently scheduled for 10:00 a.m. on July 19, 2016.

The proposed schedule will accommodate further input by parties that have not yet indicated their agreement as well as provide a process for full and fair consideration of the Settlement Agreement. The revised schedule would allow for a Commission decision on or before the December 13, 2016 Open Meeting so that new rates may go into effect by January 1, 2017:

5	Pre-Hearing Conference	Monday, August 1, 2016
6	Hearing Commences	Tuesday, August 2, 2016

8 In addition to retention of the July 19th public comment date, additional public comment
9 could be taken at the commencement of the hearing on August 2, 2016.

10 In summary, Trico and Staff request that the Hearing Division vacate the current
11 procedural schedule and schedule a procedural conference at its earliest convenience to discuss
12 modification of the procedural schedule as set forth above.


