
**JOINT REQUEST FOR EXTENSION
OF BRIEFING SCHEDULE**


23 Commission Staff, TEP, and UNS join with APS requesting a modest extension
24 of the briefing schedule. Currently, the Initial Closing Brief is due June 30 and the
25 Reply Brief is due July 18. The request is to extend the Initial Brief deadline to July 7
26 and the Reply Brief deadline to July 25.


27 APS solicited input from all parties before filing this request. It does not appear
28 that all parties responded. The parties that did respond, with the exception of one, had
no objection to extending the deadline. The parties that indicated no objection were

1 RUCO, TASC, AriSEIA, AECC, Sulphur Springs, AIC, GCSECA, ASDA, and the
2 IBEW Locals. The single responding outlier was Vote Solar. Vote Solar did not object
3 to the extension in concept, but instead requested that the Reply Brief deadline be
4 extended to July 29, instead of July 25, because Vote Solar's counsel is scheduled to be
5 in a hearing from July 18-22. Because the Reply Brief would currently be due on July
6 18 anyway, this Request only seeks an extension to July 25. If the Administrative Law
7 Judge grants Vote Solar's request for an additional four days for the Reply Brief, the
8 Initial Brief should also be extended an additional four days.
