19 **COMPANY'S COMMENTS**

23 Francesca Water Company, Inc. ("Francesca" or "Company") hereby files its  
24 comments regarding the Recommended Opinion and Order ("ROO").

25 Francesca generally supports the ROO. However, the Company does suggest one  
26 minor revision on page 10, lines 12-13 of the ROO as follows:


27 "IT IS FURTHER ORDERED that the above rates and charges shall be  
28 effective for all service provided ~~on and after August 1, 2016 during~~  
Francesca Water Company's next regular billing cycle." (~~strikethrough~~  
indicates deletion and underline indicates insertion).

1 This revision is requested so the Company can avoid the tremendous amount of work  
2 necessary to prorate charges, which is required when the authorization date set in the  
3 order does not match the billing cycle start date. This change will not adversely impact  
4 the customers.

6 Accordingly, the Company requests that the Arizona Corporation adopt the ROO  
7 with the amendment set forth above.


