
FINDINGS OF FACT


1. On August 21, 2012, the Arizona Corporation Commission (“Commission”) issued Decision No. 73352 which approved a rate increase for Mohave Electric Cooperative, Inc. (“Mohave” or “Cooperative”).

2. In addition to approving a rate increase, Decision No. 73352 required that Mohave file a full general rate by September 1, 2016 using a calendar year 2015 test year. Further, the Decision required Commission Utilities Division Staff (“Staff”) to undertake a purchased power prudence review for the Cooperative.

3. Following the issuance of Decision No. 73352, the Commission adopted A.A.C. R14-2-107 *et seq.* which became effective April 9, 2013. The new rules provide an alternative process to a full general rate case for electric and natural gas cooperatively owned utilities.




