On page 3, line 17,

INSERT the following Findings of Fact:

9. Staff acknowledges that the Commission usually prefers to itself initiate any action that may be taken in response to requests filed under A.R.S. § 40-252. However, in this instance, Staff believes that the Company's requested amendment is substantially related to the implementation of the loan surcharge mechanism. Staff therefore believes that it may be helpful to address these matters at the same time. Staff respectfully suggests that the Commission reopen this matter pursuant to A.R.S. § 40-252.

10. In the event that the Commission elects to reopen the decision and consider the Company's proposed amendments, Staff would recommend that the Commission approve the Company's request to enter into a water exchange agreement with Valley Utilities as discussed in the Company's Application to Amend Decision No. 75292. This approval should not address any specific treatment of this amendment for ratemaking purposes.
