PROCEDURAL ORDER
(Directs Filing)

BY THE COMMISSION:

On October 1, 2015, CereTel Incorporated (“CereTel”) filed with the Arizona Corporation Commission (“Commission”) an application for a Certificate of Convenience and Necessity (“CC&N”) to provide resold long distance telecommunications services in the State of Arizona.

On October 29, 2015, the Commission’s Utilities Division (“Staff”) filed a Deficiency Letter, stating CereTel needed to file an affidavit of publication stating it had provided notice of its application in all counties in which it seeks to provide services.

On March 1, 2016, CereTel filed an Amendment to its Application that included a Notice of Filing Affidavit of Publication.

On March 31, 2016, Staff filed a Sufficiency Letter, stating CereTel’s application for a CC&N had met the sufficiency requirements as outlined in the Arizona Administrative Code (“A.A.C.”) R14-2-502 and R14-2-510(E). Staff’s letter further noted that the Commission has 150 days from the date of sufficiency to complete a substantive review of CereTel’s application, which includes preparing an Order to present to the Commission at an Open Meeting.

In order to comply with the Commission’s mandated timeframes, a Recommended Order in this matter would need to be on the August 2016 Open Meeting Agenda. As of July 8, 2016, no Staff Report setting forth Staff’s recommendations with regard to CereTel’s application has been filed in this Docket.


1 Therefore, it is appropriate to suspend the time clock in this matter to allow Staff time to file its
2 recommendations.

3 IT IS THEREFORE ORDERED that Staff shall docket a filing setting forth its
4 recommendations with respect to CereTel's application on or before July 29, 2016.

5 IT IS FURTHER ORDERED that the time clock in this matter is hereby suspended.

6 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
7 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
8 hearing.
