The proposed increase to approx. \$25 from \$21 is reasonable as this amount was determined by EPCOR as the "fair value rate" for our district. It is not fair to Sun City residents to pay the proposed approx. \$41(a \$16/month increase) per month so that other districts can have their rates reduced (up to an almost \$40/month reduction)--they should pay their own "fair value rate." It seems to me that other water districts would benefit greatly by having their rates subsidized and EPCOR benefits through reduced administration by having only one district--Sun City residents reap no benefit, just increased cost. We should not subsidize other districts. This is not fair to Sun City residents and is not the right thing to do. Please vote against full consolidation.
