For these people, this basic necessity will require cutting other critical necessities like food. There is inadequate justification for raising the cost of water yet again. When a future rate increase becomes ABSOLUTELY NECESSARY in order to continue providing service then the increases should be on those consuming the very highest volume of water and thus using a disproportionate amount of this valuable limited resource. This would also provide incentive for high water usage organizations/families to seek water efficiencies. When it comes to preserving natural resources, penalties rather than discounts should apply to high usage customers.

As a resident of Sun City I am totally against waste water district consolidation as proposed by EPCOR. The proposed consolidation would result in a large increase for Sun City residents, an amount of approximately \$16.00 per month. This increase would be used to lower the rates for other districts considered in this consolidation proposal. There is absolutely no justification in having elderly, fixed income seniors, support other districts through this cost transfer. Sun City residents are willing to pay a fair price for services they use, but we should not be required to support services to other districts. EPCOR claims of administrative savings by district consolidation are bogus. In this age of computerization, if they cannot achieve administrative savings by well written computer programs, the company is badly managed, and deserves no increase at all. As a retired systems analyst and computer manager, I can tell you that a well written computer program should be able to achieve the same administrative savings as consolidation. I recently had solar installed on my roof. After 3 months of APS bills I am thrilled with my savings and energy output.
