STAFF'S PROPOSED AMENDMENT  
TO THE RECOMMENDED OPINION  
AND ORDER**

Staff hereby submits a minor technical amendment to the Recommended Opinion and Order in the above-captioned docket, Kacy J. Parker d/b/a Jake's Corner Water Systems ("Jakes Corner" or "the Company"). The purpose of the amendment, which is attached to this notice, is to correctly note the status of Jake's Corner's Certificate of Convenience and Necessity ("CC&N"). The application filed in this matter sought to transfer the Company's CC&N to Management Systems, LLC. However, Jakes Corner's CC&N was revoked in 2011. It would, therefore, be more accurate to describe this matter as a grant of a CC&N, rather than a transfer. The attached amendment proposes language to accomplish this correction.
