First, I would like to say I am and always will be eternally grateful to APS for 20 of the best years of employment in my life. However, the proposed new rate increase is totally excessive. Normally. I don't comment on these matters but lately, even with a house that is under 1,500 sq. ft. and has had new sealed doors installed with extra insulation put in the attic, shade blinds on all windows and a new air conditioner, my electric bill in July was over \$300.00 which is one-third my take home APS pension and I have kept the cooling much warmer than I am comfortable with. This is where a retiree draws the line. How much more could they possibly ask of the average person? Even my 94 year old mother keeps her home so hot I worry about her safety while she is trying to save a buck. I have friends who live in homes that are so small and hot I won't visit them in the summer months and they keep ALL of their lights, radios, TVs and fans off with shades drawn and they live like animals to be able to afford their current electric bill. They won't even turn their ovens on for cooking. Paying more on their electric bill means them going without part of the groceries they would like to buy and they work for the City of Phoenix who has cut salaries and raises year after year. I have personally seen the waste APS affords itself - believe me. With so many layers of management upon management, I personally worked in a department where the management outweighed the nonmanagement employees by more than 2 to 1 with the layers of management being paid well while everyone else settled for tiny yearly raises if they were lucky enough to get a raise at all. From the retiree grapevine l hear that nothing has changed. Let's stop the waste, if I have to live on a budget as my friends and family do then APS should learn to function within their budget and their budget should not be an unending supply of money provided by rate increases via the Corporation Commission and passed onto the customers. A 5.74% rate increase is going to add almost \$20 a month minimum to the little people with small houses while retired folks don't have the benefit of offsetting the cost of that. APS pensions don't allow cost of living raises and Social Security certainly doesn't give retired people a 5.74% increase yearly. Even the County can freeze a homeowner's tax rates if they earn under a certain amount and are of a certain age, maybe our electric company could take a lesson from that. Please only allow APS only a rate increase that does not include waste, political contributions and unnecessary promotions compared to amounts of employees. They need to work more wisely and within a reasonable budget with little room for waste. Thank you and please take my words into consideration. Cynthia Butler APS Retiree

I ask that you seriously consider rejecting any rate increase of any kind for APS. The application estimates a 5.74% rate increase for consumers. Our APS and Cox Cable bills are increasing dramatically, while the consumer is struggling greatly to keep up. Those persons on fixed incomes (Social Security) had NO increase via COLA in 2015 and, due to the method used, will undoubtedly receive none this year, since the Fed will be unlikely to increase interest rates. Thus, we are still trying to pay our utility bills on 2014 income. Our middle class is drowning in debt, trying to operate on incomes that in real wages are those paid in 1996. Banks are charging interest rates substantially higher than they pay consumers. For example, my home equity loan is charged at over 4%, while I receive a paltry 0.05% on my \$50,000 money market account, used for emergencies.

I have no figures on how many in our Valley would be classed as middle income VS. upper class, but I urge you to study however many households have had to apply for monetary relief for their utility bills, and whether the curve is inching dramatically upward. I suspect that it is.

We need relief from these ever-increasing rate hikes, and kindly ask that your view of the business needs of APS be suspect, and adjudge if they really require a nearly 6% rate increase.

The Arizona Corporation Commission should be doing everything it can to encourage increased use of solar electricity in our state. APS's rate increase application discourages the use of solar electricity by making it not financially rewarding for citizens to retrofit their homes and businesses. Distributed solar electricity benefits APS by generating power for the grid and reducing the need for APS to build additional power plants. What is the difference between APS spending money to build SOLAR power plants and APS paying roof top SOLAR customers for their excess power? It seems to me that APS is attempting to squelch free market competition and retain ownership of all power sources. At 10%, APS's return on investment is more than sufficient.
