



**CLEAR SPRINGS UTILITY COMPANY, INC.
SURCHARGE TARIFFS**

Docket Nos. W-01689A-11-0401 and WS-01689A-11-0402

On June 27, 2016, per Decision No. 75590, the Arizona Corporation Commission authorized the Company to implement a WIFA Loan Surcharge, which is \$2.18 per month for a 5/8 x 3/4-inch residential meter. On June 27, 2016, per Decision No. 75590, the Commission also authorized the Company to implement an Annece Capital Loan Surcharge, which is \$.83 per month for a 5/8 x 3/4-inch residential meter. These surcharges will become effective immediately.
