18 On June 10, 2016, Clear Springs Utility Company, Inc. ("Company") filed a Rate
19 Application for the Water Division (Docket No. W-01689A-16-0187). On June 9, 2016,
20 the Company filed a Rate Application for the Sewer Division (Docket No. WS-01689A-
21 16-0184). On August 19, 2016, the Company filed a Finance Application for the Water
22 Division (Docket No. W-01689A-16-0288). On August 19, 2016, the Company filed a
23 Finance Application for the Sewer Division (Docket No. WS-01689A-16-0287).

26 These four applications are interrelated because they address the finances and
27 utility system improvements of divisions of the same utility. Further, the rates will be set
28 based, in part, on the need to generate revenue to service the proposed debt for which the

1 Company seeks authorization in the finance applications. The infrastructure being
2 constructed as proposed in the finance applications will impact the operations and
3 maintenance of the Company's utility systems, as well as revenues and expenses.
4

5 Therefore, the Company moves to consolidate these four dockets.

6 The Company discussed consolidation with the Arizona Corporation Commission
7 Staff ("Staff") attorney and the Company understands that Staff has no objection to
8 consolidating these matters.
