**STAFF'S REQUET FOR AN EXTENSION
OF TIME TO FILE STAFF REPORT**

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby requests an extension of time to file its staff report.

On June 1, 2016 Staff filed a sufficiency letter for Wayward Wind's ("Company") request for the approval of The Sale of Assets and/or Cancellation of the Certificate of Convenience and Necessity.

On June 24, 2016 the Administrative Law Judge issued a procedural order stating that Staff should file its Staff Report on or before September 2, 2016.

Staff would request an extension of two (2) months to November 2, 2016. The extension is required due to the Company having problems properly noticing the land owners in its service territory. Staff is working with the Company to resolve this issue but feels the time is needed to make certain the Company can get its notice properly done.


