NOTICE OF FILING PROPOSED
WITNESS SCHEDULE

Pursuant to the August 22, 2016 Procedural Order, Tucson Electric Power Company ("TEP" or "Company"), through undersigned counsel, hereby submits the attached Proposed Witness Schedule ("Schedule") for the evidentiary hearing commencing on September 8, 2016.

TEP contacted all of the parties and requested information regarding i) the availability of their witnesses to testify at the hearing; ii) the need for a date certain to testify; iii) whether it might be possible to stipulate into evidence the pre-filed testimony if there would be no cross-examination; and iv) whether the witness might testify telephonically if the cross-examination was anticipated to be minimal. The Company then prepared a preliminary Schedule whereby it attempted to group witnesses by general topics of testimony to the extent feasible and to identify testimony that might be stipulated or given telephonically. It is possible that additional stipulated and/or telephonic testimony may be proposed or agreed to at the pre-hearing conference scheduled for September 2, 2016 upon review of the Company's Rejoinder Testimony.

1 Over the last eight (8) days, TEP circulated three (3) drafts of the Schedule to all parties
2 seeking input in order to arrive at the final Schedule which is attached. Given the number of parties
3 and witnesses, as well as the availability of witnesses and their counsel, it was not possible to
4 accommodate every preference without creating other conflicts.¹ However, as of the time of this
5 filing, no party has indicated to the Company that it objects to the attached Schedule. Moreover, the
6 parties will have an opportunity to further discuss the Schedule with the Administrative Law Judge
7 at the September 2, 2016 Pre-Hearing Conference.
