STAFF'S REQUEST FOR
PROCEDURAL ORDER CORRECTING
DECISION NO. 75701
NUNC PRO TUNC

On August 5, 2016, the Arizona Corporation Commission ("Commission") issued Decision No. 75701 approving permanent rates for the Green Acres Water Company ("Company"). Upon review of the Decision, Commission Utilities Division Staff ("Staff") has been made aware that there appears to be a typographical error within the Decision. The Commodity rates approved in Decision No. 75701 are not defined as a per 1,000 Gallon rate. This error exists on page 18 line 12 in the Rate Design discussion and again on page 23 line 4 in the ordering paragraph.

Upon review of the record, Staff acknowledges that the Staff Report likewise mistakenly made the same error and it appears to have been carried forward into the final decision. Unless the change is made there is no indication in the commodity rates to indicate at what volume those charges are to be assessed.

For the above stated reasons, Staff respectfully requests the issuance of a procedural order correcting Decision No. 75701 *nunc pro tunc* to insert the following:

On page 18 at line 12 the following should be inserted: "(Per 1000 Gallons in all classes)"


On page 23 at line 4 the following should be inserted: "COMMODITY CHARGES:"

On page 23 at line 5 the following should be inserted: "(Per 1,000 Gallons; All Classes)"


