
As Sun City residents and ratepayers, we depend on the ACC to keep our utility and water costs as low as possible, consistent with fairness to the companies and preserving infrastructure for the State's future. Currently there are three issues for which we ask your help:

1. EPCOR Water Company has proposed consolidating the five wastewater districts. This is wrong. It makes no sense for Sun City to subsidize Anthem, Agua Fria, Mohave, and Sun City West. It is also morally and ethically wrong to impose a 50% increase for the same service upon fixed-income retirees. Please do not approve the consolidation proposal.

2. The Sun City Independent on 08/17/16 published a letter to the editor claiming that the Sun City wastewater effluent was used by the Palo Verde Nuclear Generating Station for a payment. The letter stated that the payment went to Tolleson. If this is true, payment should be changed to accrue to the ratepayers of Sun City. Please look into this situation, let us know the facts, and make the appropriate corrections.

3. APS is asking for electricity rate increases. Among these is something called "demand charge," which, for the ratepayer, seems to be a way to trick the customer into a higher bill instead of simply charging for the total kilowatt hours used. Please do not allow APS to institute a "demand charge." And keep a tight lid on all their other efforts to raise rates.




