**ORDER CORRECTING DECISION
NO. 75701 NUNC PRO TUNC**

Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

1. On September 1, 2015, Joshua Valley Utility Company, Inc. (“Joshua Valley” or “Company”) filed an application with the Arizona Corporation Commission (“Commission”) for approval of a rate increase.

2. On August 19, 2016, the Commission issued Decision No. 75701, approving a permanent increase in rates for Joshua Valley.

3. August 31, 2016, the Commission’s Utilities Division (“Staff”) filed a Request for Procedural Order Correcting Decision No. 75701 *Nunc Pro Tunc* (“Request”), stating that the Decision contained a typographical error related to the number of gallons included in the Company’s commodity rates. Specifically, Staff’s Request states that the following changes should be corrected, *Nunc Pro Tunc*, in the Decision:

1 On page 18, Line 12,
 2 INSERT: "(Per 1,000 Gallons All Classes)"
 3 On page 23, Line 4,
 4 INSERT: "COMMODITY CHARGES"
 5 On page 23, Line 5,
 6 INSERT: "(Per 1,000 Gallons All Classes)"

7 4. On the same date, Staff filed a Notice of Errata stating that Staff's Request had
 8 inadvertently referenced the company name as Green Acres Water Company rather than Joshua Valley.

9 5. Staff's Request is reasonable and therefore Decision No. 75701 should be amended,
 10 *Nunc Pro Tunc*, to correct the stated typographical errors.

11 **CONCLUSIONS OF LAW**

12 1. Joshua Valley Utility Company, Inc. is a public service corporation within the meaning
 13 of Article XV of the Arizona Constitution and A.R.S. §§ 40-250 and 40-251

14 2. The Commission has jurisdiction over Joshua Valley Utility Company, Inc. and over
 15 the subject matter of the application.

16 3. It is reasonable to correct Decision No. 75701, *Nunc Pro Tunc*, to correct the
 17 typographical errors described herein.
