 22 Liberty Utilities (Entrada Del Oro Sewer) Corp. ("Liberty EDO" or "Company")
 23 hereby responds to the Procedural Order issued on September 16, 2016, which indicates
 24 that Liberty EDO's Motion for Extension of Time to File Rebuttal Testimony; Request for
 25 Hearing Date was unclear as to whether Staff was consulted on the request for hearing and
 26

1 hearing dates.¹ Liberty EDO confirms that Staff was consulted about the Company's
2 request for hearing, that Staff does not oppose the setting of a hearing, and that Staff's
3 scheduling issues were addressed by the Company's proposal for hearing to commence on
4 or after October 13, 2016. Furthermore, counsel for the Company has conferred with
5 counsel for Staff and obtained authorization to file this response.

6 Liberty EDO respectfully requests that the Administrative Law Judge issue a
7 procedural order setting a date for hearing.
