1 Liberty Utilities (Bella Vista Water) Corp. ("Liberty Bella Vista"), Liberty Utilities (Rio Rico
2 Water & Sewer) Corp. ("Liberty Rio Rico"), the Residential Utility Consumer Office ("RUCO") and
3 the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission"), having
4 reviewed the Recommended Opinion and Order ("ROO") docketed herein on September 30, 2016,
5 jointly request that corrections be made to that ROO and further that certain schedules attached to
6 that ROO be amended as set forth herein.

21 salaries and wages for ~~shared~~ contractual services – other of \$787,602;"


