PROCEDURAL ORDER

BY THE COMMISSION:

On October 7, 2016, a Recommended Opinion and Order (“ROO”) was issued in this docket. Consideration of the ROO was tentatively scheduled for the Commission’s Open Meeting to be held on October 27 and October 28, 2016. The deadline for the parties to file exceptions to the ROO is currently October 17, 2016.

On October 11, 2016, a Hearing Division Memorandum was filed, and served on the parties, indicating that page 171 of the ROO had been replaced with a corrected page 171, a copy of which was attached to the Memorandum.

Also on October 11, 2016, Chairman Little filed correspondence indicating that the ROO will be scheduled to be heard at the Commission’s November 29, 2016 Open Meeting.

It is appropriate to extend the deadline for filing exceptions to the ROO.

IT IS THEREFORE ORDERED that **the current deadline of October 17, 2016 for filing exceptions to the Recommended Opinion and Order is hereby extended to October 31, 2016.**


