Gentlemen;

My wife and I encourage you to consider carefully all of the issues in this matter.

We installed solar panels at our Santa Cruz County home several years ago after looking long and hard at the pros & cons.

Sulfer Springs Valley Electric Coop offered a rebate program that barely made sense given the anticipated pay-back period.

We had not only the actual solar equipment to purchase, but in addition, there were considerable expenses to beef-up the roofs for the installation. They are now proposing cutting the net metering time frame to 20 years as well as increasing the monthly service charges. Their calculations include their distribution costs, but omit OUR initial out of pocket costs to install.

This is simply a "bait & switch" scheme.

Please be fair to all of us and consider our upfront costs that would never be recouped under SSVEC's request.
