Clarification of my Memorandum of October 4, 2016 regarding the docketing of documents received from the Consumer Energy Alliance.

On October 4, 2016 my office docketed a document I received via hand delivery from a representative of the Consumer Energy Alliance ("CEA."). The decision to docket and distribute the CEA document to the members of the service list conforms to standard practice at the ACC, a policy that was developed in consultation with legal counsel. It is standard practice at the Commission that comments regarding a case, received from individual members of the public, are docketed but not distributed to the service list. Comments from individuals can be so numerous that distribution of them to the service list is impractical. The CEA document in question is not a comment received from an individual member of the public. It is a report pertaining to issues relevant to the above listed dockets produced by a national organization. As such, I determined that it was better practice to docket and distribute the document in order to make all parties to the docket aware that it existed and had been delivered to my office, i.e., I was fully disclosing a communication which may be considered to be *ex parte*.

I cannot control what documents are delivered to me. All I can do, and all I have done, is to be clear, honest and open about what documents I have received from outside parties. The manner with which I did this is consistent with long standing Commission practice.
