**SECOND PROCEDURAL ORDER**  
**(Schedules a Pre-Hearing Conference)**

BY THE COMMISSION:

On October 3, 2016, the Securities Division (“Division”) of the Arizona Corporation Commission (“Commission”) filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist, for Restitution, for Administrative Penalties, and for Other Affirmative Action (“Notice”) against Ryan Miguel aka Ryan Miguel Pina aka Ryan Lee Oliver, Robert E. Hawkins, and Infinity Fuels, Inc. (collectively “Respondents”), in which the Division alleged violations of the Arizona Securities Act (“Act”) in connection with the offer and sale of securities in the form of investment contracts and/or membership interests.

On October 17, 2016, Respondents filed a Request for Hearing pursuant to Arizona Administrative Code (“A.A.C.”) R14-4-306.

Accordingly, a pre-hearing conference should be scheduled.

IT IS THEREFORE ORDERED a **pre-hearing conference** shall be held on **November 28, 2016, at 10:00 a.m.**, at the Commission’s offices, 1200 West Washington Street, Hearing Room No. 1, Phoenix, Arizona.

IT IS FURTHER ORDERED the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) is in effect and shall remain in effect until the Commission’s Decision in this matter

1 is final and non-appealable.

2 IT IS FURTHER ORDERED all parties must comply with Arizona Supreme Court Rules 31,  
3 38 and 39, and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

4 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance  
5 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the  
6 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances at  
7 all hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled  
8 for discussion, unless counsel has previously been granted permission to withdraw by the  
9 Administrative Law Judge or the Commission.

10 IT IS FURTHER ORDERED each party or prospective party shall **refer to the Procedural**  
11 **Order Regarding Consent to Email Service** issued in this matter on **October 20, 2016**, for additional  
12 information regarding the process to consent to service by email. Information regarding Consent to  
13 Email Service is also available on the Commission’s website (www.azcc.gov) by clicking on “Email  
14 Service Consent.”

15 IT IS FURTHER ORDERED the Presiding Administrative Law Judge may rescind, alter,  
16 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by  
17 ruling at hearing.
