Before granting Century Link Facility Relocation rate allowance on the consumers in Arizona, consideration has to be taken as to the following:

1. Would like to know whether there will be a forum by Century Link with to discuss this issue with consumers and if there is one then the date for such a forum should release to consumers.
2. Want to know is this facility relocation includes land purchase or lease and the length of lease agreement and costs per month or year.
3. Explain to the consumers, what was the real reason for this facility relocation to another location?
4. Explain to the consumer, what would be the outcome of the existing facility and who owns the facility and land.
5. Explain and direct the consumer the sections # where it states that consumers are to pay through rates increase for Quest/Century Link relocation expenses through the corporation article of incorporation which states that the company can have such privileges
6. Quest/Century Link shall explain with exhibits and in written calculation what is the cost estimate for such this relocation?
7. Quest/Century Link must provide maps of the specific place or location where the facility is to be relocated?
8. Quest/Century Link shall explain as to how would this facility benefit the consumers over the years?
9. What other alternative options Century Link has besides relocating this facility?
10. Is this facility new or old? If old and fully depreciated then Century Link should sell it and use the proceed toward a new facility.
11. Century Link is public company and obtains funding from the shareholders, sell more shares to the public, or borrow for lenders or exit the telephone business.
12. If the facility is fully depreciated then Century link should have set aside the accumulated depreciation for this facility use.
13. What is the reason for this facility relocation? How would it fit in with new technology since this aspect of the facility relocation was not address?
14. Century Link should consider merger option.
15. Consumers should not be made to pay for public company property since consumers would any reimbursement after the facility is sold.
