15 captioned matter with the Rate Application filed in Docket No. SW-02199A-16-0422.

16 Such relief is appropriate and will conserve judicial resources because both rate  
17 applications are for the same company. Pima's water and wastewater customer bases are  
18 largely the same, and Pima is operated and managed as one utility. The facts giving rise  
19 to these two rate applications and the legal issues presented therein are identical. Because  
20 these matters are inextricably linked, consolidation is consistent with the interests of  
21 administrative efficiency and administrative economy.
