**SECURITIES DIVISION'S RESPONSE
TO MOTION TO CONTINUE HEARING**

The Securities Division ("Division") respectfully requests that Respondents Timothy John Wales and Stacey Wales' (collectively "the Wales") Motion to Continue Hearing be denied.

Under A.A.C. R14-3-103(Q), a matter may be continued upon a showing of good cause, but the Wales have not shown good cause for the requested delay. The Wales claim that good cause exists because of time needed to conduct discovery in light of a Superior Court trial from January 10-13, 2017, but this does not amount to good cause.

Time to conduct discovery is not good cause because the Wales already had time to conduct discovery. The upcoming hearing, which begins January 30, 2017, has been set since the August 10, 2016, Second Procedural Order. It has been almost four months since the hearing was set, and the Wales could have pursued discovery during that time. The January 2017 Superior Court trial does not create good cause either. The Wales have not claimed that the date of this trial was not known in advance. The timing of the trial is just another reason that the Wales should have pursued discovery before now.
