PROCEDURAL ORDER

BY THE COMMISSION:

On January 13, 2017, Truxton Canyon Water Co., Inc. (“Truxton”) filed with the Arizona Corporation Commission (“Commission”) an application for an emergency rate surcharge.

On January 18, 2017 by Procedural Order, a procedural conference was scheduled for January 23, 2017, to discuss procedural issues related to Truxton’s application.

On January 23, 2017, procedural conference was held as scheduled. The Commission’s Utilities Division (“Staff”) and counsel for Truxton appeared at the conference.
