**PROCEDURAL ORDER**  
**REGARDING CONSENT TO EMAIL**  
**SERVICE**

BY THE COMMISSION:

On February 7, 2017, Commissioner Burns filed a Memorandum opening the above referenced docket.

**This Procedural Order notifies interested persons of the process to Consent to Email Service.**

**The Commission has created a process for parties to a non-rulemaking docket may consent to receive service by email, rather than by U.S. Mail, for all filings made in the docket.**

The process requires a party to file a Consent to Email Service and send a verification email to the Hearing Division, after which the Hearing Division will issue a Procedural Order Granting Consent to Email Service. Once an interested party's Consent to Email Service is approved, the **party will receive all filings made by a Commissioner, the Commission's Executive Director, or a Commission Division via an email containing a link to access the filing online.** These emails are automatically generated by the filing of a document with Docket Control,<sup>1</sup> specifically by the document's being scanned into the Commission's eDocket system. The party **may** also begin receiving service by email of other parties' filings made in the docket, although whether or not to provide service by email is within each party's discretion.

**The Commission encourages interested persons to consent to email service.** Email service

1 enables interested persons more promptly to receive service of filings made in a case by a  
2 Commissioner, the Commission's Executive Director, or a Commission Division and reduces both the  
3 amount of paper the Commission consumes and the Commission's postal expenses.

4 To further reduce the use of paper, the **Utilities Division shall automatically be deemed to**  
5 **have consented** to email service in any rulemaking docket,<sup>2</sup> and the **Commission requests that**  
6 **interested persons cease providing courtesy copies** of their filings to the Hearing Division.

7 **Interested persons who do not consent to email service will not be provided documents**  
8 **filed by a Commissioner, the Commission's Executive Director, or a Commission Division via**  
9 **email** and will instead continue to receive all of these documents in hard copy via the U.S. Mail.  
10 Interested persons who do not opt in to email service also may not receive hard copies of some  
11 documents filed by a Commissioner or the Commission's Executive Director, such as Amendments to  
12 Open Meeting Agenda items.

13 **This Procedural Order is issued to notify parties of the process to Consent to Email**  
14 **Service and the requirements related thereto.**

15 **In addition, because this is a generic docket, and given the extensiveness of the original**  
16 **service list, the Commission will not serve copies of future Procedural Orders in this docket**  
17 **unless and until an interested person files a Consent to Email Service as described herein.**

18 **IT IS THEREFORE ORDERED that in this generic docket, the Commission will no longer**  
19 **be providing service of each Procedural Order upon an interested person unless the Procedural**  
20 **Order imposes a requirement upon that interested person, responds to a Consent to Email**  
21 **Service filed for that interested person, or provides other information that the Commission**  
22 **desires for each interested person to receive.**

23 **IT IS FURTHER ORDERED that any interested person<sup>3</sup> may opt to receive service of all**  
24 **filings in this docket, including all filings by other interested persons, all Procedural Orders and**  
25 **Recommended Opinions and Orders/Recommended Orders issued by the Commission's Hearing**  
26 **Division, and all filings made by a Commissioner or the Commission's Executive Director, via email**

27 <sup>2</sup> In cases that do not involve the Commission's Securities Division, the Commission's Legal Division shall be included  
as counsel for the Commission Division involved in the case.

28 <sup>3</sup> This includes any person, regardless of whether the person was included in the original service list used for this docket.

1 sent to an email address provided by the interested person rather than via U.S. Mail. **To exercise the**  
2 **email service option, an interested person shall:**

- 3 1. Ensure that the party has a valid and active email address to which the party has regular  
4 and reliable access (“designated email address”);
- 5 2. Complete a Consent to Email Service using the form available on the Commission’s  
6 website ([www.azcc.gov](http://www.azcc.gov)) or a substantially similar format;
- 7 3. **File** the original and 13 copies of the **Consent to Email Service** with the Commission’s  
8 Docket Control, also providing service to each party to the service list;
- 9 4. **Send an email**, containing the party’s name and the docket number for this matter, to  
10 [HearingDivisionServicebyEmail@azcc.gov](mailto:HearingDivisionServicebyEmail@azcc.gov) from the designated email address, to allow  
11 the Hearing Division to verify the validity of the designated email address;
- 12 5. Understand and agree that service of a filing on the party shall be complete upon the  
13 first of the following to occur: (1) the sending, to the designated email address, of an  
14 email containing an electronic copy of the filing or a link to access the filing online; or  
15 (2) for a filing made by a Commissioner, the Commission’s Executive Director, or a  
16 Commission Division, the making of the filing with a service certification including  
17 coding indicating that an automatic service email for the filing shall be sent to each party  
18 whose consent to email service has been approved;
- 19 6. Understand and agree that the party may provide additional email addresses on the  
20 Consent to Email Service for individuals to whom the party desires to have service  
21 emails sent as a courtesy, but that these courtesy email addresses are not the designated  
22 email address and will not be verified; and
- 23 7. Understand and agree that the party will no longer receive service of filings in this  
24 matter through First Class U.S. Mail or any other form of hard-copy delivery, unless  
25 and until the interested person withdraws this consent through a filing made in this  
26 docket.

27 **IT IS FURTHER ORDERED that an interested person’s Consent to Email Service shall not**  
28 **become effective until a Procedural Order is issued approving the Consent to Email Service for**

1 the interested person. The Procedural Order shall be issued only after the interested person has  
2 completed steps 1 through 4 above, and the Hearing Division has verified receipt of an email from the  
3 interested person's designated email address.


4 IT IS FURTHER ORDERED that the Commission's **Utilities Division is deemed to have**

7 IT IS FURTHER ORDERED that **if the Utilities Division desires for courtesy emails to be**  
8 **sent to additional email addresses, the Utilities Division shall make a filing listing those email**  
9 **addresses.**

10 IT IS FURTHER ORDERED that an interested person's Consent to Service by Email in this  
11 docket does not change the requirement that **documents must be filed with the Commission's Docket**  
12 **Control in hard copy with an original and the requisite number of copies.**

13 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or  
14 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
15 hearing.
