PROCEDURAL ORDER

BY THE COMMISSION:

On January 26, 2017, Gila River Telecommunications, Inc. filed a formal Complaint with the Arizona Corporation Commission (“Commission”) against TracFone Wireless, Inc. d/b/a Safelink Wireless (“TracFone”), which resulted in the opening of this docket.

On February 21, 2017, TracFone filed an Unopposed Motion for Extension of Time to File Answer requesting an additional 20 days to file its Answer due to a conflict of interest with their counsel of record.

IT IS THEREFORE ORDERED that TracFone is hereby granted an extension until March 13, 2017, to file its Answer.

IT IS FURTHER ORDERED that each party or prospective party shall refer to the Procedural Order Regarding Consent to Email Service issued in this matter on February 3, 2017 for additional information regarding the process to consent to service by email. 
