PROCEDURAL ORDER

BY THE COMMISSION:

On December 23, 2016, ACME Water, LLC (“ACME”) filed with the Arizona Corporation Commission (“Commission”) an application for approval of the creation of four separate limited liability companies for ACME’s four public water systems.

On January 24, 2017, ACME filed supplemental information requested by the Commission’s Utilities Division (“Staff”).

Also on January 24, 2017, Staff filed a Sufficiency Letter stating that ACME had met the sufficiency requirements outlined in the Arizona Administrative Code.

On January 30, 2017, a Procedural Order was issued scheduling a procedural conference to be held on February 24, 2017.

On February 24, 2017, the procedural conference was convened, as scheduled, with Staff appearing through counsel, and ACME appearing through its managing member, Mr. Jim West. At that time, the parties discussed the processing of the application and other procedural matters.

On March 10, 2017, ACME filed a request to administratively close the docket stating that it is in the Company’s best interest to remain a single entity with four separate water divisions.

Since ACME no longer desires to proceed with its application, it is reasonable and appropriate to administratively close this docket. The administrative closure of this docket should not be construed as either an approval or denial by the Commission of the underlying application.
